DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This house is nearly square being two bays wide and two deep. It has horizontal overlapping clapboard siding and a tetrahedral metal roof covered with fishscale designs. There are three windows and a door on every side of the house, the windows are 2/2 with 32" x 14" panes some of which are older wavy glass. There are concrete window sills on the first floor, 40" long and 3" thick.

The structure sits on a high foundation of block pillars anchored into the ground with poured concrete. The sills may be oak and are half lapped at every pillar. (See attached drawing). Underneath the building, one can see saw-cut sills and joists.

Originally, this structure must have appeared quite symmetrical with its four equal sides containing regularly placed doors and windows. Doors cut into the east and west sides, however, and an addition to the north facade (rear) interrupt the symmetry. There is evidence that there was a porch running the entire length of the south facade (front) which was removed.

The house contains a hall, dining room, parlor and kitchen (wing) downstairs, and three bedrooms and a hall upstairs.

Much of the interior decoration remains and includes molding with two different sizes of corner blocks, Greek revival mantles, banister, doors and hardware. The present owner who is renovating the house has suspected that many of these materials came out of other buildings and indeed the difference in sizes and styles indicates this possibility.

Behind the house are two outbuildings. One, located about five yards of the northeast corner of the house is in ruins with only a partial frame standing. The frame is made of x nailed together and apparently had vertical siding nailed onto it. One door in the south side and windows. Its use is not clear although the fact that the present kitchen is located in an addition and the fact that some cooking utensils still hang on nails driven into the frame suggests that this may have been a kitchen.

At the edge of the woods directly behind the house is a privy. It is constructed of various materials, apparently scraps, including unusual doors nailed together. They are tall, narrow doors with arched tops not unlike those on older steam passenger ships. They have a definite nautical character about them.

STATEMENT OF SIGNIFICANCE

Although the later additions and alterations have changed it considerably, the house is notable for its attempt at geometrical precision. With the sides being four equal squares, the roof a tetrahedim (four equal triangles), and the windows and doors placed so regularly as to repeat themselves on opposite sides one can not help but see this building as an exercise in plane and solid geometry.

Although the interior trim contradicts this precision, it is nevertheless of importance for what it reveals about early twentieth century interior design. The same may be said for the exterior of the house, and the outbuildings in that the materials and methods used are no longer common. The privy is unique and may contain materials valuable to maritime history.


