

CAPSULE SUMMARY CT - 1152

The Chaney tobacco barn is located on a small parcel of land near Sunderland. The privately owned barn is associated with a mid-late 19th century house, as well as a small, frame, corncrib. Measuring 16 x 40 feet, the barn is oriented on a north-south axis. An unusual plan includes four openings on the west side, and one double door on the east. The small window and door at the northwest corner suggest an animal stall was located there. The area above was floored, possibly for use as a hayloft. Cinder blocks appear to have replaced earlier supports. Re-used materials are in evidence throughout the barn.

The Chaney Tobacco barn is located on the southeast side of Grover's Turn Road. This barn is associated with a mid-late-19th century house (which has been extensively altered), as well as a small frame corncrib. The area surrounding these structures has reverted to woods or has been subdivided as residential property.

The Chaney Tobacco barn measures 16 x 40 feet and is oriented on a north-south axis. The plan is rather unusual with four openings facing west and one double door facing east. Cinder blocks support the structure at five foot intervals along the south, east and west sides. A ground laid sill supports the structure on the north. Peeled log posts are set at four foot intervals down the barn's main axis, with two set perpendicular to the northernmost door.

This barn appears to have been built of some re-used materials. The bulk of the structure is comprised of circular sawn wood and wire nails, however. The standing seam metal roof is supported by windbraces and two collars. The small window and door at the northwest corner suggests an animal stall was located here, but no interior details were identified to support this. The area above the northwest corner was floored, apparently for use as a hayloft.

Prepare both a summary paragraph of significance and a general statement of history and support.

The Chaney tobacco barn is of modern construction, post-dating 1880. Peeled log tier poles and its small irregular plan suggest a pre-1940's date as does the present owner's recollection that this barn was constructed by her grandfather. The window /door configuration at the northwest corner suggests that the structure was also used as a stable, with the floored area above (accessed by the small door) used for hay storage.

Geographic Organization: Western Shore, Chesapeake Bay, Calvert County
Chronological/Developmental Period: 1900-present
Resource Type(s): tobacco barn, stable, hayloft

Directed historical research would greatly assist in placing this structure and its builder/users into a particular historic context.




