DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This tobacco house is somewhat unusual in that its original size measures 24' x 33' in width and depth. It is, however, a three part barn with three transverse sills. All of the sills and plates are continuous averaging 8" x 12" in thickness.

Most of the timbers in the frame are hewn and joined by mortise and tenon with 1 - 1 $\frac{1}{2}$ " thick trunnels. Each upright is diagonally braced.

The siding varies in type although on the west end it consists of riven clapboards made of feather-edged chestnut cut in pieces 4' long and 5" wide. It is presumeable the oldest if not the original siding.

The roof still has wooden shingles on it although they are covered by a metal one.

In such a plan, one would expect 12 - 14' high doors on each facade, narrow doors on the ends and 8' wide doors on the sides on alternate sides of the central transverse arch.

The doors are batten-doors and cut nails were extracted.

The doorways appear altered, however, insofar as there are clapboards and mortised and tenoned studs at these spots.

The barn is in bad repair and scheduled for demolition. The sheds have already collapsed making measurement nearly impossible. A prize was discerned among the ruins.

The floor of the main section contained evidence of a root pit.

STATEMENT OF SIGNIFICANCE

Although unusual because of its size, this barn is valuable as it documents early plans and construction for a particular type of structure and like so many others it is a dramatic example of their future. Being in a state of decay and being in the way of modern development, it was demolished as this report was being prepared.

A further point of significance rests in the probability that this barn was part of His Lordships Favor are of the oldest plantations in Calvert County (see CLVT-19)


