Located at 6500 Long Beach Drive, St. Leonard, the building is a single story frame dwelling resting on concrete and steel piers overlooking the Chesapeake Bay. Constructed in 1930, the building served as a pavilion and sales office of the community of Long Beach. Modifications include the addition of a kitchen in the 1930s and a bathroom in 1942. Recent alterations consist of replacement windows and new deck. Although interior photographs were not available, inspection by Calvert County revealed that the building interior has been gutted by fire. Severe landscape changes have been the result of severe storms. Summer rental communities developed along the Chesapeake in the early twentieth century, many of the Long Beach houses have been converted to full-time occupancy. This building was associated with the speculative venture for approximately twenty years. Due to the fire and later alterations, the historic integrity and function of the original building as a beachfront community sales office has been compromised. In my opinion, the Rockhill property is not eligible for the National Register.






