Eureka Lodge No. 36 is located at 5583 Mackall Road in St. Leonard, Calvert County, Maryland. Constructed circa 1949, the meeting hall was built for the Eureka Lodge No. 36, Free and Accepted Masons of Maryland. It served as their primary meeting place until 1968, when the property was sold to the Brooks Methodist Church, which is located directly across the street. Prior to construction of Eureka Lodge No. 36, the property was owned by the Calvert Lodge of Grand United Order of Odd Fellows No. 2171, who had owned the property since 1884. Both the Eureka Lodge No. 36 and the Calvert Lodge of Grand United Order of Odd Fellows No. 2171 had African-American memberships. Eureka Lodge No. 36 is characteristic of the African-American fraternal lodges that were constructed in Calvert County in the middle of the 20th century.

Constructed circa 1949, the masonry building features a concrete block structural system and foundation. Standing two stories in height and two bays in width, the building is covered by a front-gabled roof clad in standing seam metal. An interior-end brick chimney with a corbeled cap rises above the northern slope of the roof. The window openings all contain multi-light metal sash windows with paired casements set beneath fixed transoms. Concrete-block buttresses at the center of each wall detail the side elevations.

Eureka Lodge No. 36 is located at 5583 Mackall Road in St. Leonard, Calvert County, Maryland. Situated close to the road with large trees surrounding it, the meeting hall is sited directly across the street from Brooks United Methodist Church. Constructed circa 1949, the masonry building features a concrete block structural system and foundation. Standing two stories in height and two bays in width, the building is covered by a front-gabled roof clad in standing seam metal. An interior-end brick chimney with a corbeled cap rises above the northern slope of the roof. The window openings all contain multi-light metal sash windows with paired casements set beneath fixed transoms. Concrete-block buttresses at the center of each wall detail the side elevations.

EXTERIOR DESCRIPTION

The façade or east elevation is pierced by a single-leaf side entry with a five-panel wood door and a concrete lug lintel. To the north of this opening is a paired window, also with a concrete lug lintel. Like those located throughout the building, the window consists of eight-light casement windows set beneath two-light fixed transoms. This is the only paired window on the building. These openings are mimicked at the second story by two single window openings, also with metal industrial windows. Unlike the windows on the first story, these windows do not have lug lintels. This elevation is further detailed by asbestos shingles in the gable end.

The north elevation of Eureka Lodge No. 36 is three bays in width with a centrally located concrete block buttress. Flanking the buttress on both the first and second stories are metal industrial windows. These windows on the first story are capped by concrete lug lintels. At the northwest corner of this elevation is a single-leaf door opening that has been boarded shut with plywood. Visible detailing is confined to the rowlock brick sill.

Like the façade, the west elevation is also two bays wide with asbestos shingles in the gable end. At both the first and second stories are two metal industrial windows. Those on the first story feature concrete lug lintels.

The south elevation is similar to the north elevation with a centrally located concrete-block buttress. The buttress is flanked at both the first and second stories by metal industrial windows. The first story is further pierced by an additional metal industrial window. All of the windows on the first story feature concrete lug lintels.

INTERIOR DESCRIPTION

The interior of the building was not accessible at the time of survey.

HISTORY OF EUREKA LODGE NO. 36

The property on which Eureka Lodge No. 36 now stands was originally owned by James and Nora Thomas, who sold the quarter-acre-tract of land to the Calvert Lodge of Grand United Order of Odd Fellows No. 2171 on April 11, 1884 for \$45. The Odd Fellows constructed a meeting hall on this location and it first appears on historic maps in 1902. At this time, the United States Geological Survey map of Calvert County showed the topography of the area and the presence of buildings. However, the use of the building was not noted on the map. Oral history states that this older building was demolished and that the current building was erected circa 1949. This supposition is supported by historic deeds, architectural detailing, and building materials.

The Odd Fellows retained ownership of the tract of land until February 2, 1949, when it was sold to the Eureka Lodge No. 36, Free and Accepted Masons of Maryland for five dollars. Masons Eugene O. Johnson, Edward Boome, and Nathan Smith acted as Trustees for the Eureka Lodge. The Masons continued to meet at this hall in St. Leonard for nearly twenty years, before selling the property to the Brooks Methodist Church in 1968. At that time, the church acquired four additional parcels of land from St. Lukes Methodist Episcopal Church and Parsonage, Rebecca Bourne, James and Ida Parker, and Orem and Lola Denton. The five parcels totaled 5.45 acres of land. The mortgage, which is recorded following the deed, records that the parcels of land were purchased for \$35,000. Eureka Lodge No. 36 was the precursor to the Carroll-Victoria Lodge of Masons, associated with Prince Hall.

Through the years, Calvert County has hosted a number of fraternal organizations, both national and regional. Whereas fraternal organizations in urban areas tend to be geared towards professional advancement, such organizations in rural locations like Calvert County with highly dispersed populations serve a more basic social function in bringing together individuals who might otherwise have little contact with their neighbors. Yet, even in rural communities, fraternal organizations were a means to political recognition and commercial networking, and prominent local citizens invariably belong to one or several fraternal organizations. Historically, the largest and most well established of these were the freemasons, or Ancient, Free and Accepted Masons, who established themselves in Prince Frederick by 1869.

The Masons, or Freemasons, are a ritual-based fraternal brotherhood dating back to the 16th century. The Masons developed out of medieval builders' guilds and they view God as the Great Architect and builders as doing God's work. (1) Freemasons, united by their common belief in one creator, proclaim their dedication to brotherly love, or fraternity, "relief," or charity, and truth to himself, God, country, fellow man and family. (2) Although founded and originally based in Great Britain, the Masons reached their greatest strength in the United States between the last third of the 19th century and the first third of the 20th century. In 1879, it was estimated that there were 550,000 Freemasons in the United States, a number that grew dramatically in the following fifty years, reaching over three million by 1925. (3) "By the 1920s most towns in the United States boasted a lodge of Freemasons, and every lodge had a room, a "Mason's Holy House," dedicated and set aside for the performance of Masonic rituals." (4)



ST. LEONARD, CALVERT COUNTY, MD




