DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

According to members of the neighborhood, this little building was Wilson Mason's undertaker's parlor. The building appears to be a 14' square with a 6 $\frac{1}{2}$ ' addition on the back (S.). It has a hipped roof, windows and is of frame construction. Perhaps the most notable feature is the 6 $\frac{1}{2}$ ' x 26' porch on the north facade. This porch is almost twice as long as the building extending on either side of it for six feet. It is supported by squared and chamfered posts.

The interior is quite plain (it was used as a residence at one time) and consists of the 14' square room and the smaller 14' x 6' room. The larger room had a space heater connected to a chimney on the west side.

Wilson Mason was a member of the prominent black family which owned over a hundred acres just a short distance west of Prince Frederick on Route 231. During the first half of the 20th Century, an entire black neighborhood has grown up on this land. The building served that community as an undertaker's parlor between 19 and 19 .


