DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

When seen from a distance the building appears to be a two-story frame farmhouse with an L-plan. It is four bays wide and two deep with an entrance in the second bay from the west end. It is covered by a small portico. The clapboards have been covered on the first story by asbestos siding. The gable-end roof is covered with sheet metal. An interior flue-chimney exits on the east end and another occupies the northwest corner of the main block. A single story kitchen addition on the rear (North) facade creates the L-plan.

The chief significance of this house, however, is that it contains a 1 1/2 story log structure which it apparently evolved from. The section forming the southwest corner of the house has walls constructed of squared logs which have been V-notched and laid to a height of 1 1/2 stories (to the top of the asbestos siding seen in photograph). The east wall of that room occupying the west end is not of log construction, it is presumed that it was replaced by a plaster wall when the house was enlarged.

The original house appears to have been one room down/one up in plan measuring 15' in width and 17 in depth. Single story frame kitchen additions are not uncommon on such structures. It would appear to have had entrance directly opposite each other in the north and south sides. The east and north walls have obviously been rebuilt so fenestration is a matter of conjecture. The 2/2 window of the west and south log walls were probably 6/6 originally.






