DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

All Saints' Church is located in the triangle formed by the intersections of Maryland Route 4, Maryland Route 2, and Lower Marlboro Road (Maryland Route 262), south of Sunderland, Maryland.

This Georgian structure is of Flemish bond brick with random glazed headers. It is three bays wide and four deep. All the walls are composed of a series of round-headed brick arches recessed to the ground level. In these panels are set the windows and doors on two stories. The windows are all six-over-six with segmental arches and old shutters. The water table is composed of a flat projecting brick, topped by a cyma reversa mold, topped by a cyma recta. The church has a gently sloping "A" roof.

The interior walls of the church are a series of square piers and recessed two-story round-headed arches into which the windows are set. The north and south walls have galleries, each supported on five square piers. The east and the west walls have round windows on the second story level. The box pews have simple paneling. The church presents a well-restored, pleasing appearance.

STATEMENT OF SIGNIFICANCE

The history of the present (1972) All Saints' Church building is unusual because it is so well documented. Due to All Saints' being a "state church" the published volumes of the Archives of Maryland contain pertinent documented source material on the building. Special reference is given to the establishment of All Saints' Parish in 1692 and to the erection of the present church building between 1774 and 1777. The original vestry books refer to additions made in 1703 to the first church structure (1695), which building is no longer extant. The Works Progress Administration (WPA) compiled the Inventory of the Church Archives of Maryland, which dates the construction of the extant building between 1774 and 1777. It also names Cleland and Heathman as the builders.

This extant building, the second on this site, was built with county taxes while Thomas Claggett (1743-1816) was the Rector. He later became the first Bishop of the Protestant Episcopal faith to be consecrated in America.

Calvert County taxes, authorized by the government of Maryland, paid for the present All Saints' Church building. In 1774, when construction began, the Church of England was the official government-supported church in Maryland. Since the establishment of the official church in 1692, the creation and establishment of parishes, the erection of church buildings, the purchase of church property, the format of church worship and other ecclesiastical concerns fell under the control of the Maryland Assembly and the Governor. The Bishop of London also exercised control over the Maryland church. He appointed the first minister to All Saints' Church, Thomas Cockshutt (or Cockshute), who received from the Colonial government a twenty pound (£20) bounty for accepting the Calvert County post. That eighteenth century vestrymen were viewed as civil officials is indicated by the fact that the justices of Calvert County appointed the first All Saints' Church vestry in 1692.



All Saints is one of the original Parishes of Maryland. The Act titled "Act for the Service of Almighty God and the Establishment of the Protestant Religion within the Province," passed by the Assembly at St. Mary's in 1692, provided that counties be laid out into parishes and that each county sheriff collect a tax of 40 pounds of tobacco for every taxable person, such tax to be used to build and support Churches or Chapels.

Calvert County, among the earliest counties (established in 1654), was divided into 6 hundreds, each being a division of land containing 100 families. In 1693 it was laid out into 4 parishes: Christ Church, All Saints, St. Paul's and All Faiths, the latter two being across the Patuxent River. All Saints Parish included all the land north of Hunting Creek.

The first Vestry of All Saints was elected in February 1693 and the first building, a log structure, was erected between 1693 and 1694, just northeast of the present church. The site was an acre of land donated by Thomas Kemp from the property known as "Kemp's Desire," and is described as "on the cross-road of Severn Ridge path and the road leading to Coxtown." In 1703 the church was enlarged by the addition of 15 feet and continued in use, with frequent repairs, for 70 years.

In 1774 the present church was started under the rectorship of the Reverend Thomas John Clagett, later the first Bishop ever consecrated on American soil. An old document dated May 2, 1777, addressed to the Sheriff of Calvert County, directed him to pay the contractors "the money and tobacco which was levied at last November Court," since they had satisfactorily completed the church. The actual amount is nowhere stated.

All Saints is sixty feet long, fifty feet wide and two stories high. Its brick walls are a fine example of round-arch paneling, covered with traditional ivy. The windows are the original clear glass and the old paneled galleries remain on the sides. Outside huge Canadian hemlocks shade two direct entrances to the main aisles that lead to the paneled pews. The old pew doors remain.

Some of the old records have been destroyed by fire, but those remaining provide a fascinating picture of the early church of Maryland. They reveal many of the business affairs for which the Vestrymen were largely responsible. They had to collect the tax in their respective districts or pay it themselves, and they were fined 50 pounds of tobacco for missing a Vestry meeting. They sold the pews as property. Early rectors, sent from England by Lord Baltimore, were responsible to the Vestrymen for their credentials. All church repairs necessary were determined by them, the work was inspected and paid for only if they deemed it satisfactorily done. In some instances it is reported they refused to pay. Annually they reported their proceedings to the Colonial Governor.

In most instances the currency was tobacco, the "40 per poll" supporting the church. The rector was paid in tobacco, the sexton received 900 pounds per annum, the clerk 500. Other entries, such as one in 1704, "To Mr. Dallam, 500 pounds for a journey to Annapolis, if necessary to see the Governor," and, in 1708, "Mr. Seager 30 pounds for putting up a hitching post." Tobacco was the money of early Maryland and is today Southern Maryland's money crop.

Constant effort was made to improve the Church and yard. We read such items as an order for "an iron dipper, chain and lock for the spring," and "an upping block" in 1725, presumably to assist ladies into their carriages. There were frequent orders to England, such as one in 1734 for "1 purple velvet cushion with gold fringe, 1 large prayer book, 1 new surplice for a man of middle stature, and 1 decent stone font." The work of the church was very important in every freeman's life.

Should not all Marylanders be proud of this part of their heritage and put forth their utmost efforts to maintain it?






