
Section 7 Description

The historic dwelling described in the inventory form was moved to Anne Arundel County in 1995, and a new dwelling constructed on the site. A dilapidated privy sits to the northeast of the dwelling.

The only standing building associated with the historic dwelling and described in the earlier inventory form is the nineteenth-century tobacco barn located to the west, at 2210 Ponds Wood Road. In size, shape, and materials the tobacco barn retains its earlier characteristics; however, it appears that two of the four transverse sills have been removed. The south section of the barn also appears to have been enclosed at some time after the original survey. This section has a plywood floor and patio sliders enclosing the room on the south. Additional openings have been cut into the exterior of the south and east sheds. The barn is now used for storage.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Most of the attention paid to Robinson's Rest has been devoted to the small dwelling which is indeed an interesting problem. Although specific dates have not been pinned down, the oldest portion of the house (south wing with exterior chimney) is conceivably an Eighteenth Century structure and certainly early Nineteenth Century. The house has been made an historic district and receives the protection of the Calvert County Historic District Ordinance.

Unfortunately the same can not be said for the barn and in fact relatively little has been said at all. Inspection of the interior suggests that it might be as old as the oldest portion of the house. Mrs. Arlene Hutchins' research turned up evidence that William R. Sewell built "a dwelling house, tobacco house, and fences" at Robinsons Rest prior to 1814. Whether or not this is the same tobacco house is uncertain but there can be little doubt that the barn is quite old.

The building is divided into thirds by four transverse sills. Like the other beams in the building they are hand hewn, average 8" x 11" in thickness and are joined by mortise-and-tenon with 1" diameter trunnels. The original barn (withous shed additions measures 23'10" in length and 16'8" in width. The longest sill runs the entire length of the barn.

The three part plan allows for opposite double doors in the middle of the building (east and west sides) which are 7'6" wide and 9'6" high. Single doors of the same height are on each and (north and south). The doors appear to have their original forged strap hinges.

The south section contains a root pit.

What may be original siding remains on the south wall. It is vertical siding $\frac{1}{2}$ " thick, random width with an average of 13". It is curious to note that the gables are covered with horizontal siding.

Sheds of different periods are attached to the north, south, and east facades.


