The Donald and Kline General Store and Post Office was constructed circa 1901 at the corner of 17th Street and New York Avenue, now Bayside Road, in the town of Chesapeake Beach in Calvert County. It was built at the height of development in the resort town of Chesapeake Beach, which was platted in 1899 by the Chesapeake Beach Railway Company. Situated on Lot 25 of Block 73, the store was known by the first decades of the 20th century as the Donald and Kline General Store, named after owner John E. Donald. Like many general stores in small communities, it also served as the Chesapeake Beach Post Office for a period of time. The Donald and Kline Store is characteristic of the general store and post office in Calvert County.

The Queen Anne-style building stands two stories in height and four bays in width. The wood-frame building is clad in German siding with a wide wood sill plate and the double side-gabled roof features asphalt shingling and a boxed cornice. Characteristic of the Queen Anne style of architecture, the building features alternating rows of modern fishscale and sawtooth shingles in the gable ends. The rebuilt porch is one story in height and three bays in width and is detailed with turned wood posts and balusters, a half-hipped roof, and scroll-sawn brackets. In the 1970s, a number of alterations were made to the building, including the rebuilding of the foundation with parged concrete blocks, the removal of the chimneys, and the replacement of all of the windows. The interior of the building was also altered, dividing the first floor into several small offices.

Constructed circa 1901, the Donald and Kline General Store and Post Office is located at 3903 17th Street in Chesapeake Beach, Calvert County, Maryland. Situated at the southeast corner of 17th Street and Bayside Road (Route 261), the Queen Anne-style building stands two stories in height and four bays in width. The wood-frame building is clad in German siding with a wide wood sill plate and the double side-gabled roof features asphalt shingling and a boxed cornice. Characteristic of the Queen Anne style of architecture, the building features alternating rows of modern fishscale and sawtooth shingles in the gable ends. The rebuilt porch is one story in height and three bays in width and is detailed with turned wood posts and balusters, a half-hipped roof, and scroll-sawn brackets. In the 1970s, a number of alterations were made to the building, including the rebuilding of the foundation with parged concrete blocks, the removal of the chimneys, and the replacement of all of the windows. The interior of the building was also altered, dividing the first floor into several small offices.

### EXTERIOR DESCRIPTION

The façade or west elevation has two separate entries on the first story, both of which are single-leaf, five-panel doors with square-edged wood surrounds. The first and second stories are both pierced by two 6/6-replacement windows with square-edged wood surrounds. Dominating the façade is a center gable peak which features modern fishscale and sawtooth wood shingles.

The double-gable roof is visible from the south elevation, with two gable ends clad in alternating rows of fishscale and sawtooth shingles. On the first story, there is one 6/6-replacement window and the second story is pierced by three 6/6-replacement windows, all of which feature square-edged wood surrounds.

The east elevation features an enclosed rear porch, which obscures the first story of the main block. It is pierced by a six-light fixed window, sliding plate glass doors, and a single-leaf four-panel, two-light door. Both doors on the enclosed porch lead to the wood deck, which was constructed between 1987 and 1991. The deck, which features square-cut balusters with ball finials on the corner posts, can also be accessed by an exterior stair. The second story of the east elevation is pierced by paired 1/1 windows and a single 6/6 window. A center gable rises above the rear roof slope and is decorated in the same manner as the center gable peak on the façade. The basement, which was created when the pier foundation was rebuilt as a solid foundation in the 1970s, can be accessed from this elevation. The parged foundation is pierced by double-leaf two-panel, nine-light wood doors.

The north elevation is similar to the south elevation, with the double-gable roof detailed with fishscale and sawtooth shingles in the gable ends. Like the south elevation, the first story features one 6/6-replacement window and the second story is pierced by three 6/6-replacement windows, all of which feature square-edged wood surrounds.

### INTERIOR DESCRIPTION

The interior of the Donald and Kline General Store was drastically altered in the 1970s, leaving little historic fabric. The first floor has been divided into several small rooms, including a reception area, four offices, a kitchenette, and a small bathroom. The floors are covered with wall-to-wall carpet, a drop ceiling with acoustic-tile panels has been installed, and the walls have been reclad with wallboard and simulated-wood paneling. Detailing the rooms on this floor are square-edged wood window casements, a six-inch-high flush wood baseboard, and square-edged door casements with a raised backband. The offices are accessed through single-leaf paneled doors with porcelain knobs. Although these doors are historic, the reconfiguration of the interior suggests that the doors are not original to the building. In the southwest corner of the building is a boxed straight stair with a round, replacement wood handrail. The steps have been carpeted and all original fabric either removed or covered. Likewise, there is a similarly detailed boxed straight stair in the northeast corner of the building. The bathroom, which is located in the enclosed porch, features a vinyl-clad floor, wallboard-clad walls, and a drop ceiling.

The second floor of the building has also been drastically altered, with the space being divided into a conference room and two offices. The floors are covered with wall-to-wall carpeting and both the ceilings and the walls are clad in wallboard. The window casements are square-edged replacements and most of the doors feature square-edged replacement casements as well. However, the two doors at the top of the main stair have original moldings. Both doors, one of which leads to the conference room and the other which leads to the office in the southeast corner, are framed by reeded surrounds with bull's eye corner blocks. The reconfiguration of the interior space combined with the numerous alterations within the building suggests that the doors, although historic, may not be original to the building. The door leading to the office is a four-panel wood door and the door leading to the conference room is a four-panel wood door with one-light that appears to have originally been an exterior door.

The basement was created in the 1970s, when the original pier foundation was replaced by the current concrete-block foundation. In the 1980s, the concrete floor was poured. Circular saw marks are visible on the beams.

The Donald and Kline General Store and Post Office was constructed circa 1901 at the corner of 17th Street and New York Avenue, now Bayside Road, in the town of Chesapeake Beach in Calvert County. It was built at the height of development in the resort town of Chesapeake Beach, which was platted in 1899 by the Chesapeake Beach Railway Company. Situated on Lot 25 of Block 73, the store was known by the first decades of the 20th century as the Donald and Kline General Store, named after owner John E. Donald. Like many general stores in small communities, it also served as the Chesapeake Beach Post Office for a period of time. The Donald and Kline Store is characteristic of the general store and post office in Calvert County.

### HISTORY OF THE DONALD AND KLINE GENERAL STORE

The Donald and Kline General Store is situated at the southern end of the town of Chesapeake Beach, which was incorporated in 1894. Prior to this time, the area was largely undeveloped. The 3,000-acre parcel of land was platted in 1899 by the Chesapeake Beach Railway Company, which was financed by Otto Mears and David Moffat. The town was linked by rail to Washington, D.C. and by water to the ports visited by steamboats. To attract visitors, the company constructed a boardwalk, wharf, and amusement park, which opened in 1900. (1) In 1901, after the opening of the amusement park, Laura Lena Carpenter purchased Lot 25 of Block 73 for \$500. Deed records indicate that the general store was constructed during her ownership. A 1912 promotional booklet for Chesapeake Beach showed a photograph of the building and labeled it as the general store and post office, "where money orders and registered letters are issued and forwarded." (2) The first post office was established in Chesapeake Beach on March 31, 1899 and service was likely operated from the general store for a number of years, as was the common practice in many rural communities. (3) An undated postcard of Chesapeake Beach shows the Donald and Kline General Store with a post office sign hanging from the porch. The postcard was simply labeled "Post Office, Chesapeake Beach, MD." Carpenter retained ownership until 1916, when she sold the property to John E. Donald for \$1,400.

The town of Chesapeake Beach was thriving by the second decade of the 20th century and a second wharf was added at 17th Street in 1914, a few blocks from the store. By 1916, the town had begun to attract a large number of visitors from both Washington and Baltimore who came to walk on the boardwalk, ride the carousel, and play games at the various establishments. "There was no attempt whatever to temper the degree of gambling on the Boardwalk...All the games were patronized freely, and Dame Fortune seemed to smile on none except those running the games." (4) The general store would have served the visitors to the resort town, as well as those who lived in Chesapeake Beach year round.

Although the general store was known as the Donald and Kline Store for a number of years, John and Lucy Donald owned the property for only a short period, between 1916 and 1918, and Kline does not appear as an owner in any of the deeds. On November 11, 1918, John and Lucy Donald sold the store to Charles Buckmaster for \$2,000. Eleven years later, he purchased the adjacent parcel of land, Lot 24, from the Chesapeake Beach Hotel Company. A number of restrictive covenants were placed in this

deed, preventing Buckmaster from operating a place of amusement, a gambling establishment, or a manufacturing establishment on the premises. Spirituous or malt liquors could not be made, sold, or kept for sale on the property. Additionally, the deed stated that a house no less than \$2,500 could be erected and that no person of African-American descent could own the property. (5) During Buckmaster's ownership, the town of Chesapeake Beach entered an economic decline, spurred by the increased ease of visitation to the Atlantic coastline resorts. In 1930, part of the boardwalk was replaced by Seaside Park and, in 1933, a hurricane destroyed the remaining portion. The destruction of the boardwalk combined with the Great Depression further impacted the resort community and with the advent of World War II in 1941, steamboats no longer called at Chesapeake Beach, ending much of its fame as a resort community.

Buckmaster retained ownership of both Lots 24 and 25 until August 23, 1945, when he sold the property to joint-tenants John Herbert and John A. Herbert. The Herberts retained ownership of the building for a few years, selling the property, including both lots of land, to John Merry in 1951. The property remained in the Merry family until 1969, when it was sold to Lloyd and Henni Hall, who owned the store until 1976. At that time, it was sold to Robinwood, Inc. and, in 1985, Issam F. El-Damalouji purchased it. During the second half of the 20th century, the building was used for a variety of different establishments, including a doctor's office, a pizza place, a beer hall, and a plumbing contractor's office. The current owners, Bruce and Rebecca Wahl, purchased the property in 1991 for use as offices for the Chesapeake Computer Group. In 1997, the Wahls were awarded a Calvert County Historic Preservation Project Award for their rehabilitation of the building. (6)

### THE GENERAL STORE IN CALVERT COUNTY

The Donald and Kline General Store and Post Office is one of a number of general stores that served the residents of Calvert County during the early 20th century. The building type is particularly significant not only on a practical level, but as a social outlet for widely dispersed rural residents, as well. General stores in Calvert County were located in small towns or along rural transportation routes, both land and water, particularly crossroads, waterway landings, and at railroad freight or flag stops. In Calvert County, most of the known general stores date to the late 19th and early 20th centuries and adopt the form of a late-Victorian-era dwelling. They are two-story wood-frame buildings with gable or cross-gable roofs and wide front or side porches, a form more suggestive of a residence than a commercial building. The Donald and Kline General Store fits within this description. This may relate to the fact that most known general stores in Calvert County were either initially built as dwellings, with the store being built onto or into them at a later date, or the store was originally built in conjunction with a residence. Often the proprietor of the store would live in the building or would rent out the residence to family or employees.

The "general" store was so named because of the general nature of items carried. First and foremost in the country general store was the agricultural and livestock merchandise such as feed, seeds for planting, small tools and supplies such as rope and nails. Fishing, oystering and crabbing supplies such as bait, nets and cages would have been sold in many stores, as well, particularly in the late 19th and early 20th centuries with the rise of the seafood industry in Calvert County. Basic food items, primarily dry goods such as flour and salt, were carried as well, and to a lesser extent perishable items such as freshly-butchered meats and dairy products. Availability of perishable items such as meats, dairy products, fruits and vegetable, before refrigeration became readily accessible in the second quarter of the 20th century would have been periodic, with local butchers or farmers delivering fresh items in relatively small quantities. Some storeowners stocked freshly butchered meat from their own livestock for sale in the store. Most county residents, however, would have such items supplied on their own farm. Already prepared food, such as is common in gas station convenience stores today, was uncommon in the late 19th and early 20th centuries, but by the mid-20th century many general stores offered prepared foods such as cold cut sandwiches or even had a grill.

Tobacco products, toiletries, newspapers and other periodical publications and medicines were an essential component of the general store, which featured a variety of painkillers, tonics and elixirs, and other general remedies. General stores frequently carried sweets and sodas, as well, the latter deriving from general store medicine tonics and achieving its current popularity by

introduction in country general stores of the late 19th and early 20th centuries. Many general stores also carried cloth, or basic apparel for the rural residents engaged in agricultural or maritime pursuits. Standard items included farming and fishing apparel such as overalls and cotton shirts or waterproof gear, underwear, socks and shoes, as well as more luxury items such as collared shirts, dresses and hats. Small gifts and toys were also common in the general store. Following the introduction of gasoline-powered automobiles and boats, gasoline fuel pumps became a major component to the general store, along automobile, railroad and water routes.

In addition to stocking basic goods and necessities, the country general store also provided a variety of services to the rural and small town resident. As in the case of the Donald and Kline General Store, general stores frequently contained local post offices where patrons could retrieve and post mail, or send money orders. General stores were often the first, and sometimes the only, location in the area to have a telephone, and residents would travel substantial distances to make a telephone call.

Country general stores were more than just places to purchase goods. Wide front porches with chairs or interior seating areas arranged around wood heating stoves were provided for the customers by the proprietor specifically to encourage social interaction which preserved the customer base and provided the proprietor with the opportunity to visit and catch up on local news and gossip. Local residents and store proprietors knew one another, sometimes their entire lives, and visits to the store for both business and social purposes became part of their routine.

During the day, both men and women, black and white, would gather and socialize in the general store, as opposed to other meeting places such as schools and churches, the latter which were not only segregated by race, but very often sex as well. Evenings, however, when the general store stayed open late, were largely reserved for the men of the community who would gather on the porches in the summer or around the wood stove in the winter to talk, play cards or checkers, or listen to the radio. Single men were known to have spent just about every night at their local general store, whereas married men visited less frequently.

General stores began to decline in popularity and number following World War II, largely due to the appearance of supermarkets, department stores, and other specialized merchandise stores. Some general stores adapted to the changes taking place by becoming gas station convenience stores that catered less to the local community and more to transient patrons. Other general stores were converted into liquor stores or other businesses such as the Donald and Kline General Store that has been converted into office space. Some stores were turned into residences or simply abandoned when the business was no longer financially viable. A small percentage of late-19th- and early-20th-century general stores have survived in something like their original function. The significance of this once prevalent building type, however, is apparent from the great numbers that used to exist in the county, and from the memories of county residents who grew up around the general store.

Donald and Kline General Store

Eventhough Chesapeake Beach was conceived of and existed as a summer resort, there were many full-time residents in both summer and winter. Their needs were the same as other rural towns and the importance of a general store-post office can not be underestimated. This store is pictured in an early advertisement for the resort and its importance to communications as well as commerce was recognized at that time.

Although altered in modern times, the Donald and Kline Store retains its six gables with the fishscale shingles that help preserve the character of this late Victorian resort.



Donald and Kline General Store

This structure sits close to the road on the southeast corner of the intersection of New York Avenue and 17th Street. It is a white clapboard building with a distinguishing feature of six gables, one in the front (w), one in the back (e), and two on each side.

In the early part of the 20th Century, when Chesapeake Beach was a new and thriving resort town, this building served the dual purpose of being a general store and a post office.

At the moment it is abandoned, its last use being that of a pizza parlor. The first floor front (w) and back (e) have been altered by additions but the upper story has maintained its original appearance. A photograph of this building appears in an advertising booklet published around 1910 - 1912. In it one can see that there was originally a covered porch with four gingerbread supports, metal roof and wide floor boards. A sign hung on the porch saying postoffice. The first floor was essentially three bays wide, a wide main door was in the exact center with a sash window on either side. There were two windows on the upper front which appears smaller than those on the first floor, all had shutters. The photo also shows another door in the front part on the far south end.

The front gable in the old photograph is decorated with fishscale shingles. There was a chimney in the middle of the building as there is now.

This porch has been replaced by a more modern store front. There is still a center door but it is flanked by two large glass windows, the whole of which is encased in a redwood colored enclosure. There is a glassed-in porch in the rear (east side) and a small wood addition on the south side on the building that does not appear in the early photograph. In the pamphlet, this photo is identified as follows:

"The above picture represents the General Store of Donald and Kline. Here also is located the Post Office where money orders and registered letters are issued and rewarded."
