This is one of many houses in Lower Marlboro whose late 19th century exterior belies its earlier interior. The large, two-story frame house was remodeled many times, resulting in a total of eight different types of moldings in the interior trim. The first two floors display a variety of 19th century and early 20th century woodwork. The finished attic is divided into three rooms by beaded, wide board partitions. This area reveals late 18th century or early 19th century moldings. The hand-hewn roof members joined by wrought nails show that the frame of this house dates from that era. The thin deep roof overhang is a later extension of the original roof.

The Griffith Armiger House retains its original side-hall-double-parlor floor plan, although the large chimneys which once served those parlors are gone. Griffith Armiger, who lived into his nineties, occupied this house until his recent death.






