This house is a two-story, three bay frame building with a cross gable. There is a two story ell extension to the rear. The exterior walls are sheathed with aluminum siding. Windows have two over two pane sashes surrounded by plain architraves. The main entrance is located in the west end by of the north or front elevation.

The roof is covered with asphalt shingles. There is a central brick flue with a corbeled top. A hip roofed porch which has been partially enclosed extends across the front elevation. It is supported by chamfered posts.


