DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Two gable-roofed frame tobacco barns remain on this farm. Barn #1 measures 24' square and stands just 8' tall. Barn #2 measures 24' x 40', and stands at typical tobacco barn height of about 12'-15' at the eaves. Both barns are deteriorating.

Barn #1 stands to the south, its ridgeline running north-south. A 4' wide door is centered in either end, north and south. At the south end another door opens into the loft. Sheet metal covers the roof. Feather-edged lapped boards, some as wide as 1'5", held with cut nails sheath the walls.

The eaves construction includes a thick, flat false plate. Two posts divide each side wall into three bays. Each bay includes three studs in its construction. Angle braces strengthen the frame. Two sets of horizontal rails are attached to the interior of each wall to support rails holding tobacco.

Barn #2 incorporates sheds on its south and east sides. The two exposed sides of the barn retain 4' riven clapboards held with cut nails. A deteriorating wood shingle roof covers the building, which stands on brick piers.

The roof's ridgeline runs east-west. Its apex is mortised, tenoned, and pegged. The collar beams are half-lapped and nailed. The rafters rest on a flat false plate at the eaves. The wall construction comprises posts, studs, cross rails, and angle braces.


