This house faces south onto Huntingtown Road. It is a two-story, framed and weatherboarded, three-bay house with a side-passage-parlor plan and an original two-story, two room plan ell. It was probably built about 1900. The house is heated by interior brick stove flues. The gable roof is covered with decoratively molded sheet metal. The windows are glazed with two-over-two double-hung sash. A one-story hipped-roof porch supported by Doric columns shelters the facade. The east end of the porch has been enclosed to create an extra room. The remainder of the porch is screened in. Aluminum siding and awnings are recent additions.

The structure is covered with aluminum siding. There is a partially enclosed hipped roof porch which is supported with round pillars. Brick chimneys with pronounced corbels at their tops are located inside the end walls.






