DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two-story frame house measures five bays wide by two bays deep. A gable roof covers the building. An extensive porch shelters the facade. A rear kitchen addition extends the house.

The north facade's central entrance includes sidelights and a transom. A structural seam to the right of this bay suggests two building periods. An off-center cross-gable corresponds to the two western bays. The porch, which continues around the east end, features round tapered posts and a plain balustrade. Louvered shutters flank the six over six sash windows.

A brick chimney heats the center of the west section. Plain architraves and German siding finish the building.




