DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two-story frame house measures three bays wide by one bay deep. A prominent cross-gable distinguishes the facade. The gable-roofed house includes a front porch and a rear kitchen. 2/2 sash windows light the dwelling.

A small two over two sash window flanked by tiny louvered shutters lights the cross-gable. The north facade's porch has been enclosed and modernized to provide an addition. Brick stove-flue chimneys heat the center of the house and the south end of the two-story kitchen ell.

Patterned metal shingles cover the roof of the weather-boarded structure, which rests on a concrete-covered foundation.


