This abandoned two-story frame farmhouse includes several sections: a two-bay main block, a one-bay addition to the east, and a one-story kitchen to the north with a shed-roofed eastern extension.

Interior brick stove flue chimneys heat the center of the main house and the eastern shed. Six over six sash windows trimmed in narrow bars light the house. Sheets of asphalt cover the entire roof, as well as the walls of the original section. The eastern addition is sheathed in lapped weatherboards.
