Plain lapped weatherboards cover this simple two-story frame dwelling. The small house measures two bays wide by one bay deep. A gable roof covers the house. A one-story kitchen section adds space to the house.

The north facade includes a western entrance. An interior brick stove-flue chimney heats the east end. Plain square posts, scrollwork brackets, and a weatherboarded balustrade complete the porch. Four over four sash windows light the house.

Asphalt shingles cover the roof. Weatherboards sheath the building. The house is presently abandoned.
