Early 20th century

This typical two-story frame cross-gable farmhouse includes a two-story kitchen to the west. The kitchen measures one bay square, while the main block runs three bays long by one deep. The attractive north entrance on the east facade features sidelights and a transept. The southern stove flue and north entrance suggest a side-hall single-parlor plan. Another stove flue rises in the west gable end of the kitchen. A hip-roofed porch covers the east facade.

A modern gambrel-roofed barn and auxiliary out-buildings complete the farm.


