DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Although the frame-and-clapboard building contains modern materials, its plan and exterior create a Nineteenth Century appearance. This is derived in part from the single room plan but even more so from the massive stone chimney on the west end. The base and shoulder of this chimney (first 8 1/2') are made of fieldstone, brick rubble, and mortar. It measures 3' in depth and 6' in width. The stack is brick. This chimney serves a large fireplace within that is covered with a mantel that is 9' long and 3" thick. It was roughly hewn and retains the gouges of an axe.

Such chimneys and fireplaces are common to Nineteenth Century tenant houses and many houses built by blacks during the late Nineteenth Century. Mr. Smith, however, remembers Cox building this house and explains the chimney by saying that the builder was an "old fashioned" fella who designed the building for his own use.

The main block is 24' long and c. 14 1/2' deep. The room on the east end appears to be an addition measuring 12' x 13'. There is a small hallway between the two.

STATEMENT OF SIGNIFICANCE _____

James Smith has been living on this farm for over forty years. The Parrans have owned the farm all of that time. Mr. Smith worked for Ben Parran as a full-time carpenter for over seventeen years keeping the forty-four barns and many tenant houses in good repair. Mr. Smith does not know why this tenant house should be called "Charles Stewart" because he does not recall anyone by that name having lived here, although he does remember Clarence Stewart who lived here for a short while. According to Mr. Smith, Mike Cox built this cabin to replace another one which burned. Cox was also a carpenter for Ben Parran, and Mr. Smith remembers him building this little house.




