Early 20th century

A central cross-gable embellishes this tiny one-story cottage. A lowered opening vents this feature. The central door is flanked by windows. The cabin measures three small bays long by one small bay deep. Modern open-batten shutters dress the windows. "German" siding sheathes the dwelling. A flat-roofed addition appears at the south, or rear, of the cottage. Few cabins of this size are so attractively finished.


