DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This building appears to have started as a simple cross-gable farmhouse which now includes at least four additions. Aluminum siding and narrow shutters now create a plain, uniform appearance for the entire dwelling.

The main three-bay-long house faces the Patuxent River to the west. The east side comprises a two-story one-bay-square tower-like addition whose gable roof runs parallel to and nearly fills the cross-gable. A one-story shed-roofed addition covers this side.

A one-story gabled kitchen runs to the north from the north end. A tiny shed-roofed addition covers the north end of this kitchen. Large shed dormers nearly cover either side of the kitchen roof.


