DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Late 19th Century

An extensive porch crossing five bays on both the south and west sides distinguishes this substantial two-story frame dwelling. Turned posts and jigsaw brackets support the porch roof. The west-facing cross-gable as well as the other gables are sheathed in decorative shingles. German siding sheathes the rest of the building.

The main west-facing block measures two bays deep, by six bays long on the first floor and five bays long on the second floor. A two-story three-bay "L" runs to the east at the south end. Chimneys heat the main gables as well as the east kitchen gable. The east end of the porch on the south side of the kitchen has been enclosed.

2/2 sash windows light the house. Doors occupy the third and fifth bays on the main facade, and the center bay on the kitchen's south side. The irregular fenestration suggests that the main block may have originated as a one or two story building comprising the three northern bays. It would have included a parlor to the north and a stair hall to the south. The three bays south of that may have been a one-story kitchen.


