The main three-bay facade of this two-story frame cross-gable farmhouse faces the Patuxent River to the south. The main block measures two bays deep and includes two consecutive two-story additions to the north. The first addition stands two bays long and is heated by a south chimney. The second, one-bay-square, addition is heated at its north end.

A screened porch covers the south and east sides. An enclosed porch crosses the east side of the two additions.

This farm includes three barns and two sheds along a lane running to the west of the dwelling. The first barn features a gambrel roof. The next barn is a small gabled frame building. The last barn has a steep gable roofline. Sheds cover its east and south sides.


