This house is a two story, three bay frame structure with a central cross-gable. It is sheathed with plain lapped wooden siding. The original windows have been replaced with single pane sashes. The main entrance is located in the center bay of the front or east elevation. It has no transom and there is no decorative molding associated with the architrave. A porch with a low hipped roof supported by doric pillars extends across the front. A pair of brick chimneys with corbeling at their tops are located at the interior of the house near its center.
