DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The west-facing facade of this two-story frame house presents five bays at the first floor level, but four bays on the second floor. Two additions to the south and a contemporary one-story kitchen to the north share a north-south gable orientation with the main block. A fine porch featuring turned balusters and scrollwork brackets crosses the northwest and west portions of the main house.

The facade's second floor is symmetrically fenestrated. On the first floor, two modern doors occupy the space under the third bay. Decorated brackets support the eaves.

Six over six windows light the house. A single interior brick chimney appears in the west end of the north gable. It may have had a twin to the east. Stove-flue chimneys appear at the south-center of the roof, at the exterior of the north gable-east end, and at the exterior of the kitchen's north gable. Enclosed shed-roofed additions cover the kitchen's east and west sides.

Standing-seam metal covers the roof, while asbestos shingles cover the walls.






