According to information prepared by SHA, the Horst Mueller House, located at 1825 Hallowing Point Rd, Prince Frederick vicinity, does not meet any of the National Register Criteria for listing. The large frame gable front house, constructed c. 1915, has been expanded to the east and west over the years and altered in a number of other ways. It fails to convey a strong sense of the turn-of-the century farmhouse. It is not located in any known historic district.

This frame house is a two story, two bay gable front L-shaped structure covered with aluminum siding. Windows have two over two pane sashes and are trimmed with aluminum shutters. The main entrance is located in the east bay of the gabled south elevation. It is reminiscent of the Greek Revival style with a broad transom and side-lights. Windows in the south elevation of the gable are double pairs separated by thick mullions. A modern brick chimney is built against the east end of the ell extension. There is a wrap-around one story porch supported by doric pillars.
