This L-shaped two-story frame farmhouse includes a two-story kitchen section to the rear. Porches cross the west and south sides of the main section, and the south side of the kitchen.

Each side of the west-facing house contains a single bay. The kitchen measures two bays long by one bay deep. Two over two windows light the house. Scrollwork brackets and turned posts distinguish the porches. Asbestos shingles cover the house.

A small, square outbuilding capped by a pyramid roof stands behind the house.


