DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two-story frame house faces the Patuxent River to the south. It includes the five-bay main section, a one-story kitchen to the east, and a two-story ell to the north. Porches cover the north side of all sections.

A two-story hip-roofed addition extends from the north end of the ell. Interior brick chimneys appear at either side of the main block's central bay, at the east end of the kitchen, and at the north end of the ell.

Two over two windows light the house. Asphalt shingles cover the roof. German siding sheathes the walls.


