DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two-story frame farmhouse includes a rear ell. The east-facing facade measures three bays long. A hip-roofed porch crosses the facade, while an enclosed shed-roofed porch fills the "L".

Two over two windows light the house. Interior brick stove-flue chimneys heat the north end of the main block and the west end of the ell. Corrugated sheet metal covers the roof. The house has been encased in aluminum siding.




