Little other than the overall configuration remains intact in this two-story frame farmhouse. The three-bay east-facing facade includes an enclosed porch and a central cross-gable.

A two-bay shed addition adjoining the south end is lit by a six over six window. A stove-flue chimney heats the rear corner.

Modern windows have replaced the originals. The entire house has been covered with aluminum siding. Asphalt shingles cover the roof.

A frame tobacco barn, covered with a gambrel roof extended on one side, stands northwest of the house.


