This west facing frame house is in deteriorated condition. Two sections, a 1½ story house to the north and its one story southern kitchen, make up this house. The three bay facade includes a right-hand entrance. A gabled wall dormer lit by a pair of joined windows lights the facade's half story.

A brick stove flue chimney heats the juncture of the two sections. Openings of both sections are boarded over. The one-bay-square kitchen was originally covered with wooden shingles. The main house was covered with plain lapped weatherboards. Asbestos shingles cover the original siding on both sections.


