This three-bay, gable-roofed, framed and weatherboarded I-house faces southeast, overlooking Maryland Route 231. The foundation is sheathed in decoratively molded sheet metal. There are brick stove flues located just inside the gable end wall. There is a front-facing gable over the central bay. The roof is sheathed in decoratively molded sheet metal. Extensions include a one-story rear shed addition and a hipped-roof one-story screened-in front porch. It is supported by turned posts and embellished with pierced and sawn brackets. Original windows have two-over-two double-hung sash. Behind the house is a framed and vertical-boarded tobacco barn with an attached stripping shed. There is also one other small outbuilding.

This two-story frame farmhouse exhibits a central cross-gable on its east-facing facade. This three-bay facade includes a central entrance and is covered by a screened porch with jigsaw brackets.

Two over two windows framed in flat boards light the house. A lunette window appears in the cross-gable. An interior brick chimney heats either gable end.

Metal shingles cover the roof, and asbestos shingles cover the walls. The house stands on concrete block piers.

A modern one-story shed-roofed addition extends to the rear.






