This late nineteenth century two-story framed and weatherboarded dwelling faces north onto 4th Street. The gable roof is covered with standing-seam sheet metal. There is an added brick chimney on the exterior of the west gable end. The three-bay facade with side entrance is lengthened to the west by a fourth bay incorporated into a polygonal gable-end projection. The original section of the house probably has a two-room plan. There is a two-story framed and weatherboarded ell and a one-story shed addition. The facade is sheltered by a hipped-roof, screened-in porch supported by tapering Doric columns.

Two over two windows flanked by louvered shutters light the house. Brick chimneys heat the west end and ell.

Metal shingles cover the roof. Weatherboards sheathe the walls.
