The house faces northeast on a hilltop overlooking the old main street of Huntingtown. It is a substantial framed and weatherboarded Colonial Revival House, probably built in the 1920's. It is ostensibly a one-and-a-half-story structure, for the second story is accommodated by broad monitor dormers on the front and rear. The steep gable roof has a kick at the eaves. The house is heated by a central brick chimney. The windows are glazed with a one-over-one double-hung sash. The two-bay facade indicates that there is a side-passage plan. There is a one-story one-bay original wing on the north end of the house. Aluminum siding and louvred blinds are a recent addition.


