The house faces southeast on the side of Highway 2/4. It is set on a low brick foundation. In form, it is like a truncated shotgun house. It is two bays long. The house is a one-story, framed and weatherboarded, gable-roofed house with a two-bay gable-end facade. The original windows have six-over-six double-hung sash. There is a brick stove flue located at the back of the original two-room section. A screened-in porch conceals the facade. There is a one-bay rear ell with a northeast-facing cross gable. There is a concrete-block stove flue in this addition. A shed addition to the southwest side gives the facade an extra bay.






PRINCE FREDERICK
