It appears that someone is slowly remodeling this house. It is located behind a new professional building and actually faces south toward Stoakley Road. It is set back from this road and is surrounded by several vertical-boarded outbuildings. It is a two-story L-plan house with a gable roof and original two over two double-hung sash. The original weatherboarding has been replaced with wood shingles. There is a brick stove flue located near the juncture of the two wings of the L shape. The single-bay side wing has the main entrance. There is a hipped-roof porch that shelters the south and east sides of the front-facing wing. A one-story one-bay rear ell has a second stove flue. The eaves of the gable roof flair to meet the cornice. There are segmental-arched windows in the side- and front-facing gables.




