This house was built in the first one or two decades of this century. It faces east on Highway 2/4. Set on concrete piers, the house is a framed and weatherboarded bungalow of the sort with a gable roof ridgeline running parallel to the facade. It has a three-bay facade composed of a central entrance and flanking paired windows. There are six-over-one double hung sash, a rear shed addition, and a gable-roofed dormer on the front face of the roof. There is one interior, and one exterior brick end chimney. There is a modern one-bay one-story wing built onto the south side of the house. Aluminum siding has been added.
