DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Beneath the brown shingles of this farmhouse are clapboards of whitewash. They are attached to the frame with various types of nails. Cut nails were removed from the northwest corner.

Beneath the house one can see hand hewn joists which run north and south in the east wing and in the west wing. The east wing rests upon a brick foundation which raises it off the ground C. 24". Exposed sills on the north wing reveal mortise and tenon construction with trunnels.

The fenestration varies in each section. There are 9/9 windows in the west wing. In the east wing, there are 6/6 downstairs and 3/6 upstairs. Both sections have gabled-end roofs covered with wooden shingles, the west wing has a pedimented dormer with stylized "deep cornices."

There is an exterior chimney on the east end of the building.

The interior is not without plan. The east wing is one up/one down with a hall and stairs on the west end. This portion of the house possesses rather elegant molding throughout with corner blocks that have five pointed stars cut into them. The panelled door with side windows also has a series of smaller star blocks worked into its design. The fireplace is bricked up but there is a wooden mantel remaining which has some decorative carving on it.

The west wing is one and a half story possessing one full room downstairs. It has a bricked up fireplace with a similar mantel that also has turned columns. The kitchen or north wing is attached to this room.

Exposed areas show that both sections contain machine cut lathes with plaster.

Behind the house off of the northwest corner is a meathouse constructed of round logs joined by notching.. It is covered with vertical weatherboards. Cut nails were pulled from the southwest corner.

STATEMENT OF SIGNIFICANCE

The 1967 survey evaluates this house as having an 18th Century wing onto which the main block was built C. 1820. This is possible.

Examination of the interior reveals little about the west wing which is supposed to be the 18th Century portion. There is a single pedimented dormer on that portion with characteristics of the Greek Revival.

The interior of the main block bares out the assertion that it is Federal Era, although 1820 may be too early. The plan is end-hall with one room down and one up. In addition to Adamsesque-like mantles the hall and parlor are trimmed with molding with corner-blocks. Each cornerblock has a five point star carved into it. The South entrance is somewhat elaborate. The same star-block pattern is worked in miniature around the sidelights of a four-paired door.

Fisk Kimball gives 1818 as the first appearance of moulded bands and cornerblocks with Latrobes Decatur House being the nearest example. In dating Huntley in Fairfax County at 1820, the presence of corner-blocks was sited as an item of sophistication indicative of an architects involvement. Although possible, it seems unlikely this little frame farmhouse is the work of an architect and to date it at 1820 seems to place it in a class with the brick mansions of Washington's famous families like Van Ness, Decatur Mason et al.

It is no less valuable for being later, for its decorations are actually unique, but it seems safer to date it C. 1830.



From the slope of the roof it appears that this part of the house is c. 1820. The smallwing on the left is 2 bays wide with its own door. The roof is very steep, and pierced by one pedimented dormer. There is no evidence of an exterior chimney in this wing, but the pitch of the roof and the 9/9 windows are evidence that this is probably 18th century and originally was the main house. At present it is a Negro tenant farmer's house and very run down in condition.</p>


CT-8 ① Farmhouse, Grover House, Owings




