This framed early twentieth-century commercial building is oriented with its gable end toward the south. The structure is six bays long. Set on a low brick foundation, this building has a single wide central entrance with one domestic bay flanking each side. The walls are sheathed with aluminum siding or tarpaper, and the roof is covered with standing seam sheet metal. There is an early shed addition which extends the length of the east side. This addition has a parapeted false front. The front hipped porch is relatively new. Hooks imbedded in the exposed rafter ends have something to do with the building's early or original functions.
