This house faces southwest. It is set on stone piers. It is a two-story single-pile, framed and weatherboarded two-bay house, built around the turn of the century. The original weatherboards have now been replaced with asbestos shingles. The windows have six-over-six double-hung sash. The interior brick gable-end chimney has been dismantled. The gable roof is covered with corrugated sheet metal. There is a one-story flat-roofed screened-in front porch and a two-story rear shed and a one-story shed built onto the north-west gable end. The house is in poor condition.
