This substantial two-story square-plan brick house faces west onto Armory Road. Built around 1900, the structure has a three-bay facade, three-over-one double-hung sash, and a steep pyramidal roof. There is a central brick chimney. A gabled dormer is built into each of the planes of the roof. A shed-roofed, screened-in porch shelters the west and north sides of the first story. Detailing of the house has a vaguely classical look.
