This house faces northwest onto Maryland Route 231. It is a side-gable bungalow, a one-and-a-half-story, framed and weatherboarded house set on a concrete foundation. The asbestos-shingled gable roof kicks out at the front and rear to accommodate a front porch and a shed extension on the rear. There is a central brick chimney. The upper story is lit by a front-facing gabled dormer. The broad eaves have no cornice and are visually supported by corbelled wooden brackets. The original windows have six-over-one double-hung sash. The front porch is supported by straight square piers with rails and balusters between.




PRINCE FREDERICK
