This turn-of-the-century house faces northwest onto Maryland Route 231. Set on a foundation of decoratively molded concrete block, this rectangular-plan, double-pile, one-and-a-half-story framed and weatherboarded dwelling is visually dominated by its sheltering hipped roof. There is a central brick chimney and a hipped dormer on the front plane of the roof. The house is four bays long, and the original sash are six over one. The fenestration of the facade is hidden by a porch that has been closed in and glazed with modern louvred windows. There is a gable-roofed one-bay wing built onto the northeast side. Aluminum siding has been added.


