



This one-story concrete-block building faces east onto Courthouse Square. The facade is veneered with brick, and the flat roof of the structure is concealed behind a brick parapet wall. Pairs of six-over-six double-hung-sash windows flank both sides of a classical doorway with a segmental-arched pediment. This structure dates from the 1950s or 1960s.
