This one-story wood-framed gable-roofed commercial building is oriented with its gable end facing north onto 4th Street. The roof, which is covered with standing-seam sheet metal, is hidden behind a parapet end wall. The structure was probably originally sheathed with weatherboards, but is now veneered with pressed brick. The building is two bays long with a one-bay rear addition. The two-bay facade includes a side door and a commercial-sized window filled with domestic-sized panes of glass.




