Set on a concrete-block foundation, it is a one-story framed and asbestos-shingled house, oriented with its gable end toward the street. The roof is covered with asphalt shingles. It is two bays long and has a three-bay facade with a central doorway. There is a central concrete-block stove flue. The windows have six-over-one double-hung sash. There is a small front gable-roofed porch.


