This house is sited on a hill, facing west toward Maryland Route 765. It is a two-story three-bay turn-of-the-century house with a gable roof interrupted by a front-facing cross-gable over what was originally the central bay. The house is wood framed, but is now veneered with brick. The windows and doors have also been modernized. There is an off-center interior brick chimney. The one-story hipped-roof front porch has also been encased in brick. A new two-story brick extension has been built onto the north gable-end wall.






Solomons Island Rd. South


