This two-story framed and weatherboarded four-square house faces west onto Maryland Route 765. The ridgeline of the hipped roof runs perpendicular to the facade. Hipped dormers are set into the north and south faces of the roof. There is a central brick chimney. The roof is covered with asphalt shingles. The two-bay facade indicates a side-passage plan. The windows have one-over-one double-hung sash. There are two-story polygonal bays on both the north and south sides of the house. A two-story cross wing has also been added to the north end wall. A one-story hipped-roof porch set on Doric columns shelters the west and south sides of the house. On the south end, the porch is screened in.






Solomons Island Rd. South


