This one-story, four-room-plan, framed and weatherboarded dwelling faces west onto Maryland Route 765. It is set on a new molded concrete foundation. It has an asphalt-shingled hipped roof with the ridgeline running perpendicular to the facade. The roof extends out to shelter the original porch, a third of which has been weatherboarded over. The remainder of the porch is screened in. Behind this porch, two bays, one window and one door are still visible. Original windows of this house are glazed with six-over-one sash. The most distinctive decorative feature of the house is the shingled cornice. There is a concrete-block rear addition and garage. The house was built about 1900.


